III. The promotion of the officers is further subject to the condition that no disciplinary/vigilance case is pending against the officers. In case any disciplinary /vigilance case of type referred to in DOP&T OM No: 22011 /4/91-Estt(A) dated 14.09.1992 is pending against the official or some punishment like stoppage of increment is current, he/she should not be promoted and matter should be reported to this office immediately.

IV. Any request for declination of promotion will not be entertained by Administration due to administrative exigencies.

V. The officers now promoted, in case they are officiating on local arrangement basis in the grade of Accounts Officer by an order of the Circle, should be reverted to their substantive grade and be promoted afresh in compliance with this order, after giving a break for one day.

VI. The seniority of the officers will be communicated separately.

VII. On promotion to the grade of AO on regular basis, the pay of the officials will be fixed as per the instructions issued vide OM NO: 1-50/2008-PAT(BSNL) dated 05.03.2009 read with letter no. 400-61/2004-Pers.I dated 18.01.2007.

VIII. Posting of officer(s) to the sensitive/non-sensitive posts should be done by the Circle as per prescribed norms circulated by DoT and O&M branch of BSNL Corporate Office from time to time.

IX. The officers now retained in this order are liable to be transferred during next rotational transfer in administrative exigencies.

X. The Circle IFAs are requested to relieve these officers promptly on or before 15.05.2010 without waiting for substitutes to join.

XI. The leave, if any requested by the officer, under transfer, should not be granted under any circumstances by the Circle(s) where they are working presently without prior permission of the CO BSNL. The officer can apply for leave to the Competent Authority at the new place of posting, who will sanction the same if it is justified in the normal course.

XII. Necessary charge report may be sent to all concerned including Manager (SEA), CO BSNL, New Delhi.
