A ascering was held at Hyderahad on 11.08.2017 on the aforesaid issue, under the Chairmanship of Dir(HR), BSNL Board. The PGM(Pext)BSNLCO and the CGM/GM(UR)/IFAs of both the Circles (ie AP Circle and TS Circle) were present in the meeting. The Dar(FIR), BSNL in her opening remarks stated that a revenue share-based principle has been adopted to distribute/rationalize the assers and staff among both the Circles in this biforcation. She also thanked both the CGMs for taking the initiatives to result into a smooth transition and independent functioning of both the Circles.

However, few issues still remained un-resolved, and accordingly those pending aspects have been discussed and decisions taken thereto are minuted below;

Suggegation of Staff:

Pers Wing of BSNLCO has already conveyed the basic distribution of executives/non-executives among bath the Circles, till the Restg Wing of BSNLCO formally intimates the Sanctioned Strength in each Codic/Goade to be maintained at the Circles (Pers Wing has already referred the case to restg wing for this purpose).

Details of staff swallability at present and sraff under the roll of transfer is projected in Annes-1. Dir[FIR), BSNL has sought for a time-bound release of all the officials under the

roll of transfer for smooth functioning of the Circle Office at vijaywada.

However, a transfer order has been issued by TS Circle transferring 30 aumaers of GrD Staff from Hyderaland to Vijeywada, which is yet to be implemented. GM(HR)Vijaywada has been seeking an early release of these staff for smooth functioning of the Circle Office at Vijaywada. It has been decided that the release of these officials will be implemented in phases: 10 numbers of GrD staff worth be released by 30 59,2017, another 10 numbers of GLD staff by 31.10.2017 and finally, the last 10 numbers of GrD staff would be released by TS Circle by 51.03,2018.

Dir(HR), BSNL has instructed for strict adherence of the aforesaid timeline by TS Circle. Order issued by Corporate Office on earlier occasion allowing the staff of the edjacent SSAs to be pulled to man the Circle office at Vijaywada stands withdrawn with immediate effect.

2. Service Books:

As stated, majority of the Service Books of the staff/executives scrying/pined in AP Circle are yet to be transported and kept in its Circle Office at Vijaywada, CGM,TS informed that preparatory works have already been completed for the same and accordingly, a target date of 15.08.2017 has been fixed

3. Segregation of Common Functionings
