Sub:- **Cases of Refusal of Promotion to the grade of DGM(Adhoc) by Executives – disposal thereof.**

The undersigned is directed to refer to the cases of refusal of promotion to DGM(adhoc) grade which have been forwarded to this office as per list (**Annexure**). The merits of the cases have been considered and it is found that the refusal of promotion are based on improperly explained reasons primarily involving family/personal/health reasons. Promotion form an important milestone in the career of an executive and are also important for the growth of organisation. The importance of these promotions was explained vide DIR(HR), BSNL Board D.O. letter of even number dated 11-04-2016.

Accordingly, the requests for refusal of promotion in the grade of DGM on adhoc basis (**Annexure**) have been considered on the basis of reasons cited by the executives by the Competent Authority and the same could not be accepted on merits.

The executives (as in **Annexure**) are enjoined/directed to join (if not already joined) in the **promoted post till 20-07-2016** as a final opportunity, failing which suitable administrative action may be proceeded against these executives as per existing provisions. The respective CGMs, shall cause **relieving of such executives w.e.f. 21-07-2016** in order to get the pending orders implemented in the interest of the Company.

This exercise will have the effect of disposing off the representations from the executives in the present context.
