**ORDER**

Subject: **Refusal of Promotion in the grade of DGM on adhoc basis- acceptance thereof.**

This has reference to this office letters of even number dated 08/07/2016 & 13/07/2016 whereby the refusal requests of the executives were rejected based on reasons cited for refusal. However, the Competent Authority has decided to review these cases in view of purported hardships faced by these executives.

Accordingly, in view of certain difficulties being faced by these executives, the competent authority has decided it appropriate to accept the requests for refusal of promotion of the following AGM/DEs rejected earlier plus 3 more new requests (**listed in Annexure**) of Telecom Operation Stream to the grade of DGM on adhoc basis issued vide this office orders of even number dated 03-03-2016, 31-03-2016, from the dates of refusal as mentioned against their names:

2. In line with existing guidelines on the issue, these executives *will not be considered for any promotion (either regular or adhoc or even Look After Arrangement)* for a period of one year or till the preparation of next panel, whichever is later, from the date of refusal of promotion by the executive.

3. As a result of these refusals, the executives will be liable to any administrative consequences on their seniority or promotion to higher grade in future as the case may be.
