Maharashtra Telecom Circle is hereby authorized to procure 2052 (Two thousand and fifty two only) Paper seals from the Government Press, Nasik, required for affixing on ballot boxes being taken on loan from the Election Commission of India for conduct of 1st membership verification for electing majority representative Association(s) of Executives in BSNL. On the basis of information from Circles, a requirement of approx. 1026 ballot boxes has been projected to the Election Commission of India to make available to BSNL on loan basis. 

2. The date of Polling has been fixed for 07.12.2016. Accordingly, it is requested that the necessary action for procurement of 2052 Paper Seals may be taken immediately so that the paper seals are collected by the Circles by 21st Nov., 2016.

With a view to save avoidable expenditure, the General Manager Telecom., Nasik, can be requested to send the paper seals by Insured Post to the Circles which expressly make a request to him for sending the paper seals by post and indicate the name and particulars of the officer to whom the letter along with paper seals need to be sent so that the concerned officer only opens the post carrying the seals. Alternatively, the CGMs also have the option to get the paper seals collected from GM, Nasik, if they so desire, by deputing a responsible officer for the same.
