**Sub: - Inordinate delay in relieving of Executives belongings to Telecom Accounts Finance Services under transfer to other Circles/Units - Relieving of such officers from BSNL CO itself through ERP - regarding.**

Transfer & posting are issued based on the requirement in a circle vis-a-vis the vacancy shortage in different grades & other administrative requirements. BSNL Corporate Office has issued many transfer orders which have not been implemented in the field and officers are not relieved from their present place of posting thereby creating a hindrance in the balanced availability of human resource. Instructions to relieve such officers are being issued from BSNL CO from time to time.

2. Accordingly, list of Executives, who are yet to be relieved by the concerned circles/units against their pending orders has been prepared and enclosed herewith for information and appropriate disposal.
3. Retention or any other modification, issued by CO BSNL in the pending orders, if any, noticed in respect of any officer in the list may be communicated to this office for making due corrections thereto.
4. In view of above, respective Heads of Circles/Units may cause releasing of the Executives by 30.06.2018 A/N positively as the last chance, else BSNL CO will be left with no other alternative except to release these officers through ERP.
5. This also disposes of all the representations received directly/indirectly/through Circle in connection with cancellation/re-allotment/retention etc.
6. It is also noticed that some of the Executives, who have already been relieved directly through the ERP or by the Concerned Circle, have not joined in the Circle, where the Executive have transferred. In this connection, Circles are requested to issue direction to such Executives, who have not joined their new place of transfer despite of relieving from their Units/Circles, at the last known address, available in the service records of the Executive to join the Circle immediately else necessary action may be taken against them as per rules.
7. Necessary compliance may be furnished to this office at the earliest.
