Sub: Refund of premium deducted after the due date i.e. Feb-2020 in respect of the members of Group Term Insurance with LIC of India.

Sir,

The undersigned is directed to refer point 7 of the Annexure to this office letter No. 1-05/2019-PAT(BSNL) dated 05.02.2020 regarding annual renewal of the Group Term Insurance Scheme. In this regard, it has come to the notice that in respect of the 26 cases of executives (list enclosed), the annual premium has been deducted from the salalries of the month of March, April and May, 2020. This is in clear violation of the instructions of this office.

- 2. The annual premium for the GTI scheme for the period from 01.03.2020 upto 28.02.2021 has already been paid to LIC of India as per the total premium deducted from the month of Feb-2020. No subsequent payments are allowed. LIC of India has declined to include these executives as members for the GTI scheme for the current year.
- 3. In view of above, it is requested to refund the premium deducted after the due date in respect of these 26 cases. As these employees are no longer member of the GTI scheme, no Insurance claim will be admissible. Recently, CA branch vide letter dated 500-65/2019-20/CA-II/GTI dated 19.06.2020 (available on BSNL Intranet) has laid down the procedure for refund of excess premium deducted from the salary. The circles may follow the same procedure for refund of premium in these 26 cases.
- 4. This is issued with the concurrence of CA branch.
