- 6.0 The crucial date for determining the regular service condition shall be 1st July, 2009.
- 7.0 Rectt. Cell may kindly expedite the conducting of the examination, as the Hon'ble CAT, Ernakulam Bench, vide order dated 21-8-2009 in TA no.6/2009 (WP(C) no. 27722/2008) (copy received on 27-8-2009), has directed to conduct the examination within 4 months.
