Sub: OA No.1358/2010 filed by AIGETOA and others Vs UOI, Ministry of Social Justice & Empowerment, CMD, BSNL and others in Hon'ble CAT, Madras Bench.

Ref: This office letter of even number dt.6.5.2011.

Sir,

As you are aware, approximately 1861 JTOs were promoted to SDE grade against the vacancy year 2008-09 under Seniority-cum-Fitness quota vide this office order dt.30.3.2011 and subsequent orders with instructions to join the promoted assignments within a period of 40 days i.e. upto 8.5.2011. However, due to the Hon'ble CAT, Madras Bench interim order dt.26.4.2011 directing for maintaining status quo in respect of the OA captioned above, the process of implementation of promotion orders under reference was stalled vide this office letter dt.6.5.2011 and all the circles were accordingly requested to comply with the following:-

- (i) No JTO promoted to SDE grade under this office order dt.30.3.2011 & subsequent orders be further relieved from today onwards to join their new posting on promotion. Further instruction in this regard will be issued in due course by this office based on Court direction & decision taken.
- (ii) Further, all the JTOs who already stand relieved by various circles and have not reported for their assigned postings so far be asked to join back as JTOs at their previous place of posting. In this regard further instruction will be given in due course by this office based on Court direction & decision taken.
- (iii) As regards the JTOs who have joined their promoted assignment w.e.f..30.4.2011 i.e.from the date Hon'ble CAT Chennai decision came to notice, till date may be asked to wait. Their promotion order with respect to the new posting may not be issued for the time being. Such cases will be decided on the basis of the directions of the Hon'ble Court in due course.
- (iv) Any other issue faced by the circles in respect of the above, may be brought to the notice of this office.

Subsequently, the subject OA filed by AIGETOA and others has been disposed of by the Hon'ble CAT, Madras vide their Order dt.24.6.2011. Since, the interim stay as mentioned above has now become infructuous, all the Telecom circles are requested to take further necessary action as follows immediately to complete the process of promotion:-

- (i) As the promotion process had been stalled w.e.f.30.4.2011 due to the interim stay of the Hon'ble Tribunal dt.26.4.2011 i.e. before completion of the stipulated period of 40 days given w.e.f 30.3.2011 i.e. upto 8.5.2011, for the promoted JTOs to join their new assignments, additional time of 15 days from the date of issue of this order i.e.upto 19.7.2011 is granted to such non-relieved JTOs.
- (ii) All the JTOs promoted to SDE grade under this office order dt.30.3.2011 & subsequent orders may accordingly be relieved immediately & well within 15 days from today onwards to join their assigned circles/ postings.
- (iii) Further, those who have joined their promotional assignment w.e.f.30.4.2011 and were asked to wait earlier under this office letter of even no. dt.6.5.2011, may be regularized in the SDE grade w.e.f. their respective date of joining, by issuing suitable promotion orders by the circle concerned.
