Sub: Voluntary contribution of one day basic pay by BSNL employees towards Prime Minister's Relief Fund for the victims of flood in Kerala State..

Sir,

In view of the unprecedented havoc caused in Kerala State by the recent flood, it has been decided that employees of BSNL be requested to rise to the occasion and help those who had suffered untold miseries and loss of life and property. Therefore, all employees of BSNL are requested to contribute voluntarily one day basic pay towards help of victims of flood in Kerala. This amount of one day basic pay should be deducted from the salary of August, 2018.

2. As this is voluntary support, those employees who are not willing to contribute may give their unwillingness in writing to AO (Cash) / (Pay Bill) of their unit. The concerned AO(Cash) / (Pay Bill) shall deduct the amount of one day basic pay from all the employees except those employees who give their unwillingness in writing. This amount should be booked under the appropriate accodes.

3. Further, it shall be noted that units/circles are only required to deduct the amount of contribution from the pay of employees. They are not authorized to make payment of the same. The payment will be made centrally by Corporate Office, BSNL at New Delhi. The amount so worked out shall be intimated separately to BFCI branch of Corporate Office BSNL latest by 15<sup>th</sup> September, 2018.

4. The contribution so made are fully exempted from Income Tax under Section 80G of Income Tax Act. 1961.

5. BSNL employees working in the affected areas of the flood in Kerala may also contribute to Prime Minister's National Relief Fund if they so desire.
