Reservation for Other Backward Classes in Civil Posts and services under the Central Public Sector Enterprises - Sub-quota for Minority Community.

The undersigned is directed to refer to this Department's O.M. No.6/45/94-DPE)SC/ST Cell) dated 27th July, 1995 and Department of Personnel & Training (DoPT)'s O.M. No.41010/2/2011-Estt (Res.) dated the 22<sup>nd</sup> December, 2011 on the subject mentioned above and to say that the DoPT vide aforesaid O.M. has intimated that the Government of India on the recommendations of National Commission for Religious and Linguistic Minorities set up to suggest criteria for identification of Linguistic Minorities, has decided to carve out a sub-quota of 4.5% for minorities, as defined under Section 2(c) of the National Commission for Minorities Act, 1992 from within the 27% reservation for OBCs. The castes/communities of the said minorities which are included in the Central list of OBCs, notified from time to time by the Ministry of Social Justice & Empowerment shall be covered within the said sub-quota.

- These instructions will have effect from 1<sup>st</sup> January, 2012 and the instructions issued already on the reservation for OBCs stand modified to that extent.
- All administrative Ministries/Departments concerned with the Central Public Sector Enterprises (CPSEs) are requested to bring this position to the notice of Chief Executives of CPSEs under their administrative control and ensure compliance of these instructions in recruitment/appointments in the CPSEs
