### ORDER

**Subject: - Promotion and posting of regular EE (C) executives to the grade of SE (C) or equivalent in JAG grade on Regular basis.**

Approval of the Competent Authority is hereby conveyed to promote the executives in the grade EE(C) **(as per Annexure- I)** to the grade of SE(C) or equivalent in JAG grade on regular basis in the IDA Scale of pay of Rs 32900-58000 (E-5) under the provisions of BSNL MSRRs with immediate effect and until further orders.

2. The Executives shall however be not promoted by the concerned Circle/Units in case:

- Disciplinary/vigilance case is pending and VC is withheld in terms of instructions contained in DoP&T O.M No. 22011/4/91-Estt.(A) dated 14.09.1992.
  - The Executive is under the currency of any penalty.
  - The Executive is on deputation to any other organization.
  - Presidential Order for absorption in BSNL not issued due to any reason.
  - The officer has resigned /taken VR/Retired/Expired as on the date of issue of the order.
  - They have not fulfilled the prescribed eligibility as per the relevant RRs.
- All such cases may be brought to the notice of this office immediately for taking further appropriate action.

3. The orders for grant of regular promotion of above-mentioned officers/executives shall be effective with immediate effect or from the date of assumption of charge of higher post whichever is later.

4. The charge-reports submitted by the executives in pursuance of aforesaid promotion order may be sent to all concerned and entries be made in HRMS/ERP/Service Book.

5. The Executives will have to successfully complete mandatory training in '**on line mode**' within two years of this order as prescribed in EPP and clarifications issued from time to time for drawing second increment as per applicable rule of EPP.

6. All the executives shall invariably be required to join their promoted post immediately and positively within 40 days from the date of issue of this order. The CGMs concerned may ensure that the station of posting order in respect of the executive(s) found fit after fulfilling the conditions as mentioned under para 2, are issued in time and such executive(s) are relieved in time so as to join their new assignment within mandated time period. *No requests/ representations will generally be entertained for change of posting, etc.*

7. In case the executive/s concerned fails to join their promoted post within the prescribed period, it will be construed that such executives are not interested to accept the promotion and to that extent, the promotion order in their case will become inoperative and they will be deemed to have refused promotion after expiry of specific period from the date of order. Such executives will not be considered for promotion (Regular/Adhoc) for a period of one year.

8. GM HR/Admn of concerned Circles/Units are required to furnish compliance of the above promotion/transfer/posting orders with regard to joining/ relieving of the promoted executives.

9. The leave, if any, requested by the executive, who is/are under transfer, should not be allowed. However, in case any executive desires leave, he/she can apply for leave to the Competent Authority only after joining the assigned place of posting and the respective Competent Authority will sanction leave, if it is considered justified, in the normal course.

10. Posting of executives to the sensitive/non-sensitive posts may be decided by the concerned circle as per prescribed norms circulated by DoT and Vigilance Branch of BSNL Corporate office from time to time.



12. Pay fixation applicable to the executive may be done in accordance with BSNL order No. 1-50/2008-PAT (BSNL), dated 05.03.2009 read with BSNL order No. 400-61/2004-Pers.I/308 dated 18.01.2007 and subsequent orders issued from this office from time to time.

13. The management reserves the right to post any officer at any place keeping in view of administrative exigencies.


