

It is informed to all units of BSNL that BSNL has been granted Unified License (All Services except ISP) in all Service Areas (**including Delhi and Mumbai**) with migration from all existing Licenses (except sui-generis& ISP) to Unified License with authorization of ILD, NLD, Access Service, PMRTS, VSAT CUG and INSAT MSS-R Services to M/s Bharat Sanchar Nigam Limited. The existing ISP License shall continue to be in operation till its expiry in July 2025. For ready reference of all, a copy of the Unified License of BSNL has been uploaded on BSNL Intranet under <u>Miscellaneous</u> link. The License – in original, is available with CS and CGM (Legal).

- 2. (a) With the grant of aforesaid Unified License, BSNL is now eligible to provide Access services (Wireline and Mobile) in Delhi and Mumbai Service Areas, in additions to other telecom services.
 - (b) Delhi LSA includes local areas served by Delhi, Ghaziabad, Faridabad, Noida and Gurgaon Telephone Exchanges.
 - Similarly, Mumbai LSA includes local areas served by Mumbai, New Mumbai and Kalyan Telephone Exchanges.
 - The concerned Circles are required to send all reports of aforesaid areas, accordingly.
