Subject:- **LDCE for promotion to the grade of SDE (Civil)/SDE (Electrical) & AE (Arch.).**


I am directed to state that it is proposed to hold the following Limited Departmental Competitive Examinations in June/July, 2011:

- a) LDCE for promotion from JTO(Civil) to SDE(Civil) for backlog vacancies upto 8.7.2009 reserved for SC/ST category candidates.
- b) LDCE for promotion from JTO(Electrical) to SDE(Electrical) for the vacancy years 2008-09 & 2009-10.
- c) LDCE for promotion from JTO(Arch.) to AE(Arch.) for the vacancy years 2009-10 & 2010-11.

2. Further, it is proposed to go for online registration of application and issue of e-Admit Card for these exams as has been done in the case of LDCE for promotion to SDE (Telecom). In order to facilitate online registration, a list of candidates in JTO(C)/JTO (E)/ JTO (Arch.) has been obtained from IT Pune Cell and the same is attached herewith. Accordingly, the following actions are required to be taken:

- a) In case any entry in the HRMS data(list attached) like category of the candidate, circle where the candidate is posted, HRMS No., Date of Birth, etc. needs correction, the same may be got corrected at the earliest and latest by 21st January, 2011 by the JTO concerned himself.
- b) In case of any missing entry, the candidates are requested to get it uploaded into the HRMS by 21.1.2011 positively.
- c) DGMs (A) of the respective circle are requested to send by 21.1.2011, the list of only those candidates out of the above lists who are not eligible to appear in above said examinations. Any corrections/additions/deletions required in the list may be got done in the HRMS itself by the concerned Circle.

It may be noted that all other candidates not appearing in the list of not eligible candidate supplied by the circle as mentioned at (c) above but appearing in the provisional list attached with this letter against the respective circle will be presumed to be eligible for the said LDCE.

3. Based on the information received vide para 2(C) above and the corrections /deletions /additions carried out in view of para 2 above, the eligible candidates finally appearing in HRMS data will only be allowed to register online and to provisionally appear in the examinations. Further, it may be noted that Exam Centre shall be allotted based on the present posting details (i.e. present circle and not present location e.g. all NTR, ND candidates will be allowed to appear from NTR, Delhi Exam. Center only) of the candidate as on the date of notification of these examinations. Exam. notification is likely to be issued in February, 2011.

4. It may kindly be noted that eligibility check, correctness of personal data of the candidates will not be verified after online registration starts and hence correction of data must be done by 21st January, 2011. Correctness of personal data in HRMS is the sole responsibility of the candidate. No request for change/correction/modification in date of birth, category of candidate, etc. shall be entertained by Recruitment Cell, BSNL C.O. at any stage after start of online registration and no manual application for appearing in the respective Exam shall be entertained.
