
(a) Consequent upon the interim relief granted by CAT Chandigarh and subsequently by PB CAT New Delhi [OA No. 1413/HP/12, MA No. 1249/12, and OA No. 1486/PB/12 as well as Principal Bench of CAT OA No. 4100/12 and MA No. 3659/12 respectively], **steps have been taken to include provisionally** for similarly placed BSNL executives (as applicants) who fulfill the following criteria:-

The provisional of inclusion of BSNL executives in DR-DGM Recruitment will be subject to:-

- (i) Service of 12 Years of post qualification working experience as on 1st August of the Recruiting Year.
- (ii) Approximate Annual Gross Salary of Rs.7 lakhs for three years upto the financial year relevant to the year of recruitment, FY 2011-12 in this case.
- (b) These changes will be applicable to BSNL executives only and other terms and conditions of eligibility will remain unchanged.
- (c) Last Date of the ONLINE Registration/ONLINE submission of FORM is 31st December 2012 (for BSNL Executives only).
- (d) Last Date of submission of computer generated FORM (putting HRMS No. of the applicant and signature on the form-Hard Copy) is 4th (four) January 2013. The demand draft should be in favor of AO (Cash), BSNL, New Delhi and should reach at the postal address to Shri Shiv Singh, AGM(DE-II), BSNL CO, Room No. 223, Eastern Court, Janpath New Delhi-1100001 by Speed/Registered post by the last date.

It is reiterated that "the candidature of the applicants/employees will be provisional and will be subject to the outcome of the Court cases. Also, the provisional candidature will be applicable only to the present round of recruitment underway".
