Sub: Procurement of Ballot Boxes from Chief Electoral Officers of the States for holding 1st membership verification process through secret ballot for electing majority representative association of executives in BSNL-regarding.

Sir,

This office has requested the Election Commission of India (ECI) vide letter of even number dated 17.10.2016 to supply Ballot Boxes for conducting the 1st membership verification for electing majority representative association of executives in BSNL. The ECI has informed BSNL vide their letter no. 51/15/2015-EMS dated 01.11.2016 (Copy enclosed) to procure the required number of ballot boxes from the Chief Electoral Officers of the States/UTs concerned.

2. Since the date of holding the election has been changed from 16.11.2016 to 07.12.2016, the ECI was requested vide this office letter of even number dated 26.10.2016 to issue necessary instructions to State Election Officers. Under Secretary Election Commission of India vide email addressed to the Chief Electoral Officers of all States & UTs has forwarded this office letter dated 26.10.2016 for taking action accordingly. A copy of this office letter dated 26.10.2016 and the e-mail of ECI, referred to above are also enclosed for information & necessary action.

3. As already mentioned that , the date of Polling has been changed from 16.11.2016 to 07.12.2016, accordingly, it is requested that prompt necessary action for procurement of Ballot Boxes from respective Chief Electoral Officers of States/Union Territories & their distribution to all the SSAs/Units under your control. Further, time schedule etc. for procurement and distribution of ballot boxes is indicated in the "Procedure for conducting membership verification...." already uploaded on intranet on 17th October 2016.

4. Further, the table attached to this office letter dated 17th October, 2016 addressed to the Election Commission of India indicates that some Circles within a State have been clubbed. In order to ensure smooth procurement and distribution of ballot boxes, the following arrangement is suggested: -

- NTR shall collect the ballot boxes on behalf of BSNL C.O. also and arrange its distribution.

- MP Circle shall collect the ballot boxes on behalf of BRBRAITT Jabalpur, T&D/Insp. Circle Jabalpur, TFs, Jabalpur & Richhai and arrange proper distribution.
- Maharashtra Circle shall collect the ballot boxes on behalf of TF Mumbai and arrange proper distribution.
- Chennai Telephone District shall collect the ballot boxes on behalf of Tamilnadu Telecom Circle also and arrange proper distribution.
- UP East Circle shall collect the ballot boxes on behalf of UP West Circle & ALTTC, Ghaziabad and arrange proper distribution.
- Kolkatta Telephone District shall collect the ballot boxes on behalf of WB Telecom Circle, Telecom Stores, Kolkatta & TF Kolkatta and arrange proper distribution.



The Commission, vide its letter of even number dated 19th June 2007, had instructed the Chief Electoral Officers of all States and Union Territories to transfer the Ballot Boxes available in their States/UTs to the concerned State Election Commission subject to the condition that they agree to return the Ballot Boxes in good condition in case of exigencies.

3. The Chief Electoral officers of all the States/UTs who have not transferred the Ballot Boxes yet to the State Election Commission concerned, are requested to provide the required number of Ballot Boxes to BSNL. The loaning will be subject to the condition that the cost of transportation of the Ballot Boxes from store to the polling stations and back will be borne by BSNL.

4. BSNL will get in touch with the concerned CEOs and inform them about the exact number of ballot boxes and the locations where they are needed.

5. The receipt of the letter may kindly be acknowledged.
