

Sub: Hon'ble Supreme Court Judgment dated 15.09.2017 in the SPL(c) No. 9574 of 2013 filed by All India Adiwasi Employees Federation against judgment dated 20.12.2012 of Hon'ble High Court of Bomby, Nagpur Bench- Appointment of candidates belonging to Halba Koshti/Halbi Koshti /Koshti, etc. castes againt vacancies reserved for the Scheduled Tribes- regarding.

Maharashtra Telecom circle has sought clarification regarding applicability of any reservation benefits to Halba koshti /Halbi kosti/koshti appointed in BSNL/DOT.

In this regard , the clarification as sought by your office are as under:-

Point	Point raised by circle	Clarification thereof
I	Whether the reservation benefits obtained on or after 28.11.2000 by employes belonging to the Halba koshti/Halbi kosti/koshti (appointed against ST vacancies) will remains unaffected	Halba koshti/Halbi kosti/koshti persons appointed against ST vacancies will be treated as false cast certificate holders in view of DOPT O.M. No. 36012/12/2013-Estt.(res.) dated 30.08.2018.
II	Whether the reservation benefit will be continued to employees belonging to the Halba koshti/Halbi kosti/koshti caste(appointed against ST vacancies)	Not applicable in view of clarification as above .
II	Whether the employees belonging to the Halba koshti/Halbi kosti/koshti caste (appointed against ST vacancies) should not get any reservation benefits irrespective of any date. If so what action is requied to taken against such officials.	The employees belonging to the Halba koshti / Halbi kosti/ koshti, etc castes are not eligible for the reservation under ST category in view of DOPT O.M. No. 36012/12/2013-Estt.(res.) dated 30.08.2018. So far as action taken against these false caste certificate holders are concerned , the action may be initiated as per guidelines reiterated vide Dir (HR)'s letter vide no.60-10/2015-SCTdated 12.12.2017.
