**Subject: Grievances of the PSU Executives vis-à-vis call for agitation by Oil Sector Executives.**

Hon'ble Sir,

We would like to submit to your kind honour that there is serious resentment in the Executives working in various PSUs who were expecting that the Government, if unable to improve upon the recommendations of the Second Pay Revision Committee for PSU Executives, will at least implement the same without dilution. But to our dismay we found that certain important recommendations of the Second Pay Revision Committee, which when implemented were expected to give a fair amount of satisfaction to the PSU Executives, have either been rejected or diluted substantially. We had at once taken up these issues with Shri Santosh Mohan Dev, Hon'ble Minister for Heavy Industries & Public Enterprises vide our letter No.AIBSNLOA/CHQ/2008/45 dated 8<sup>th</sup> December 2008. We take this opportunity to enclose a copy of the same for your kind perusal. So far, the issues raised by us in our above representation remain unresolved.

2, We are really disturbed to find that when the Government was found so generous while implementing the recommendations of sixth Central Pay Commission for the Central Government Employees, it became too harsh towards the PSU Executives while considering the recommendations of the 2<sup>nd</sup> Pay Revision Committee for them. The grievances of Oil Sector and similarly placed PSU Executives need, therefore, to be redressed urgently.

3 We, therefore, appeal to you to kindly intervene in the matter and render justice to the PSU Executives. We also extend our moral support to the Oil Sector PSU Executives.
